The undersigned is informed and believes that:

**COUNT 1**

On or about March 16, 2012, in the County of Santa Clara, State of California, the crime of MURDER, in violation of PENAL CODE SECTION 187, a Felony, was committed by ANTOLIN GARCIA TORRES who did unlawfully and with malice aforethought, kill Sierra LaMar, a human being.

(CJIC-SPC, JRS-QJ) It is further alleged that the murder of Sierra LaMar was committed while the defendant, ANTOLIN GARCIA TORRES, was engaged in and was an accomplice in the commission, the attempted commission, and the immediate flight after the commission and attempted commission, of a felony, Kidnapping in Violation of Penal Code sections 207 and 209, within the meaning of Penal Code section 190.2(a)(17).

Any defendant, including a juvenile, who is convicted of and pleads guilty and no contest to any felony offense, including any attempt to commit the offense, charged in this complaint or information is required to provide buccal swab samples, right thumbprints and a full palm print impression of each hand, and any blood specimens or other biological samples required pursuant to the DNA and Forensic Identification Database and Data Bank Act of 1998 and Penal Code section 296, et seq.

Further, attached and incorporated by reference are official reports and documents of a law enforcement agency which the complainant believes establish probable cause for the pretrial restraint of defendant ANTOLIN GARCIA TORRES, for the above-listed crimes.

Complainant therefore requests that the defendant(s) be dealt with according to law.
