

1. Court records that are not confidential by law, ordered sealed by the Court or otherwise specifically excepted by the Court, subject to the following conditions

All parties filing documents in this case must provide the Court with both an original un-redacted version of the document for filing and a redacted version of the document for the remote electronic access. The following information shall be redacted:


- Driver license numbers
- Dates of birth
- Social security numbers
- Criminal Identification and Information and National Crime Information numbers
- Addresses and phone numbers of parties, victims, witnesses, and court personnel
- Medical or psychiatric information
- Financial information
- Account numbers
- Juror names and other juror identifying information
- Any other personal identifying information not specifically listed above

2. A list of scheduled calendar events, including the date, time, and location.




