Having considered all of the relevant factors identified in California Rules of Court, Rule 2.503(e), and having provided notice to the parties and the public as required, the Court hereby orders that remote electronic access to case information for the above-entitled case shall be provided as follows:

1. Court records that are not confidential by law, ordered sealed by the Court, or otherwise specifically excepted by the Court.

All parties filing documents in this case must provide the Court with both an original un-redacted version of the document for filing and a redacted version of the document for the remote electronic access. The following information shall be redacted:

- Drivers' license numbers
- Dates of birth
- Social Security numbers

Proposed Order Re: REMOTE ELECTRONIC ACCESS TO CASE INFORMATION

- Criminal Identification and Information and National Crime Information Numbers
  - Addresses and phone numbers of parties, victims, witnesses, and court personnel
  - Medical or psychiatric information
  - Financial information
  - Account numbers
  - Juror names or other juror identifying information
  - Any other personal identifying information not specifically listed above
2. A list of scheduled calendar events, including the date, time and location.


This order shall be posted on the Court's website, and the clerk is directed to mail a copy of the order to the parties and the Judicial Council.


