

Re: People v. Garcia Torres, Case No. C1233134: proposed order re release of grand jury transcripts

Dear Judge Bonini:

This firm represents the San Jose Mercury News in the above-captioned matter. On behalf of the Mercury News, we have submitted to the Court along with this letter a proposed order regarding the release of the grand jury transcripts.

The Mercury News' proposed order provides, *inter alia*, that copies of the transcripts posted on the Santa Clara County Superior Court website should be redacted, while transcripts entered into the public file or otherwise released to the public should be unredacted. This is consistent with the Court's May 30, 2014 Standing Order regarding Remote Electronic Access to Case Information, as well as California Rule of Court 2.503(e) regarding remote electronic access. Both the Court's May 30 order and California Rule of Court 2.503(e) require that material posted online be redacted to remove personally identifying information. Neither the order nor the Rule speak to records filed in the court's public files. Accordingly, only the transcripts posted online should be redacted.


If the Court believes it appropriate to release to the public only redacted transcripts, the Mercury News respectfully requests that any Order releasing the transcripts provide that the Mercury News retains the right to object to the extent of the redactions made by counsel for Defendant.

The proposed order submitted by the Mercury News with this letter further provides that the grand jury transcripts shall be released, both online and otherwise, at 10:00 a.m. on Monday, July 14, 2014. The Mercury News requests this in order to permit the court reporter to release the transcript in an orderly fashion.

1 This Court ordered the release of the transcript of the Grand Jury proceedings
2 related to this action, and stayed its order until 5 pm on July 11, 2014;

3 This Court hereby modifies its prior order in the following manner:

4 Counsel for defendant shall redact the transcripts of the Grand Jury proceedings in a
5 manner consistent with this Court's standing order regarding Remote Electronic Access to
6 Case Information, dated May 30, 2014. Counsel for Defendant shall submit to the Court
7 the redacted transcripts.

8 The redacted transcripts of the Grand Jury proceedings are to be posted on the Santa
9 Clara County Superior Court's website.

10 Copies of the unredacted transcripts of the Grand Jury proceedings are to be made
11 available to the public.

12 The unredacted transcripts shall be released to the public, and the redacted
13 transcripts shall be posted online, at 10:00 a.m. on July 14, 2014.
