The Court read and considered the Notice of Motion for Release of Documents Pursuant to Subpoena Duces Tecum, and Declaration in Support Thereof (hereinafter "Motion") filed by The People of the State of California (hereinafter "People") on April 28, 2016. The Motion requested the release of "Any and all disciplinary records for Antolin Garcia-Torres [REDACTED]. The records are to be produced UNREDACTED." Records were produced by the Santa Clara County Department of Corrections (hereinafter "DOC") in response to the subpoena and sent directly to the court.


On May 13, 2016, in open court, both sides agreed that the court conduct an in camera review of the records to determine whether or not the records produced by the DOC were responsive to the subpoena.

The court has conducted an in camera review of all of the records produced by the DOC in response to the subpoena. There were no evident redactions to the records. Upon review of

each page of each record produced, the court did not find any records which refer or relate in any way to any disciplinary records for the defendant.

Accordingly, the motion of the People is denied.
